Building Addition in Full Swing

As the summer build season rapidly approaches, the GDCG building addition is already well underway. With a construction start date in early February, the 2,560 sqft building addition and renovation should be complete by late June.

Phase I of the project was the erection of the pre-engineered metal building addition (pictured in progress above) to provide parking capacity for nine of the fleet vehicles. Phase II of the renovation will see the existing demising wall between the insurance division offices and the warehouse removed, and the expansion of the existing corporate office space.

The renovation plan includes 14 new offices, a plans review room, and an additional conference room in the back half of the building. To get a more in-depth view of the renovation plan, please see Kevin Hess, and thank you for cooperation during GDCG's latest expansion.

CotYs 2011

The National Association of the Remodeling Industry (NARI), recently recognized Greater Dayton Building & Remodeling and Oberer Thompson Company with two regional Contractor of the Year (CotY) Awards for 2011.

Contractors from seven regions around the country vie for CotY Awards on an annual basis, and all regional winners will

now be eligible for National CotYs in select categories. GDBR & OTC received awards in the following categories:

Commercial Interior

Walnut Grove Country Club

Residential Exterior Specialty

Outdoor Living Space (The Eakle Project; Sugarcreek)

Winners were selected from a grouping of 412 contractors across 26 categories broken up by geographic regions. This is the 10th time since 2005 a GDCG company has received regional distinctions for its work, and will now vie for national honors. The company has been awarded national CotYs three times in the past five years, most recently in 2010 under the commercial specialty category for the renovation at the Melting Pot Restaurant in Centerville.

Kohl's Site Work Beats Harsh Winter

Construction on the 85,000 SF building pad for Kohl's newest store location in St. Mary's began in November with one goal: Deliver the project before March 1, 2011. Firmly entrenched between those two dates was one of the harshest winters in recent memory. To overcome the challenge of such a large scale exterior project during the year's coldest months, (See "Kohl's cont.")

the GDCG/OTC team came together to develop a site preparation method to both protect the work from inclement weather while avoiding costly soil stabilization methods. The resulting strategy was the addition of 18"-24" of compacted clay above the pad—formally known as a "surcharge"—to allow for proper protection from the elements. Two weeks before the pad delivery date, the site contractor began excavation of the surcharge, and with a little help from Mother Nature, pad certification reports were delivered four days before deadline. The plans and progress were praised by Kohl's construction managers who visited during the site work period, and construction of the building is scheduled to begin in early April.

County Corp Open House Held at Wayne Meadows

On March 10th, County Corp Development Corporation held its latest neighborhood open house at the recently-renovated Wayne Meadows project completed by Greater Dayton Construction Group. Representatives of various local organizations, including Huber Heights City Council and local media, were in attendance to tour the 4-unit property.

Renovated in fewer than 150 days, the 3,412 sqft complex features new high-efficiency Energy Star appliances and mechanical systems, two visitable units, and two fully UFAS compliant units scheduled to be occupied this month.

The project was funded by the Neighborhood Stabilization Program (NSP) which promotes the ideal of long-term / low maintenance sustainable housing options. NSP funds have also partially or completely funded several other GDCG/OTC projects, including: Twin Towers Housing, Dayton View II, West Carrollton and Clarke County Demolition projects, and the renovation of Marvin Gardens.

Renovated Marvin Gardens

Highlights City's South Entrance

Located prominently on one of Dayton's highest traffic entrances to the city, Marvin Gardens was in desperate need of a facelift. Saint Mary Development Corporation purchased the foreclosed building originally built in 1910 utilizing funds available through the NSP2 (Neighborhood Stabilization Program 2) with plans to redevelop it as low to moderate income housing. After selecting GDCG/OTC to perform the work, the highly challenging renovation project got off to a slow start due to issues with tenant eviction and "squatters." Once the renovation was underway, the project team also encountered the additional obstacles of mold and asbestos discoveries, and insect infestations.

Working closely with SMDC and the Oregon Group Architects, GDCG/OTC completed work on the renovations, which included restoration of the original clay roof tiles and brick veneer. The interior scope was highlighted by adaptive reuse methods, which included: salvaging original hardwood floors, plaster walls, and glazed tile fireplace surrounds. Other new amenities were added including energy efficient fixtures, vinyl flooring, and kitchen cabinets.

Miami Township Awards Oberer Thompson \$8+ Million Project

After significant work by the Oberer-Thompson estimating department, along with the efforts of Oberer's main office, OTC was awarded the \$8+ Million Miami Township Fire Station 51 and Public Works Facility project.

The site, just over 25 acres in size, is located on Wood Rd. at the southern most edge of Montgomery County. Proposed site work for the project includes both private and public utilities, drives, detention areas, paving, fencing, and extensive landscaping and hardscaping.

The buildings include a new public works facility (53,000 sqft), and a new 13,200 sqft fire station (rendering shown above). Both buildings are masonry bearing with structural steel frames and roofs. The public works building will incorporate vehicle storage and maintenance areas, along with wash bays and administrative offices.

The fire station will feature three truck bays, dormitories for township firefighters, a fitness room, and kitchen facilities. In addition to these areas, the space will also include training and classroom settings with administrative offices. The building also has a tower and confined space area for training purposes.

A third building rounds out the total scope of the project. This 4,800 sqft, fabric covered structure will serve as a salt storage facility for the Township.

The project is scheduled to start in mid April.
